NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL ASSESSMENT AND PROPOSED FINDING OF NO SIGNIFICANT IMPACT FOR JACKS VALLEY DISTRICT DEVELOPMENT AT U.S. AIR FORCE ACADEMY, COLORADO

The United States Air Force (USAF) completed the Jacks Valley District Plan (JVDP) in September 2020, which identifies requirements for the improvement of the physical infrastructure and functionality of Jacks Valley, United States Air Force Academy (USAFA), Colorado. The JVDP identified current and future mission, facilities, and infrastructure requirements; development constraints and opportunities; and land use relationships. The USAF has prepared a Draft Environmental Assessment (EA) to consider the potential impacts from the proposal to implement 28 projects that were identified as development priorities in the JVDP. The proposed district development projects include the following types of activities: facility construction and demolition, land modification, roads and trails improvements, and utilities and communications installation. The Draft EA assumes that all 28 projects would be constructed within the next 5 years.

The Draft EA, prepared in accordance with the National Environmental Policy Act (NEPA), Council on Environmental Quality regulations, and USAF instructions for implementing NEPA, evaluates potential impacts of the Proposed Actions on the environment, as well as No Action Alternatives. Based on the analyses, the USAF anticipates preparing a Finding of No Significant Impact (FONSI), to include a Finding of No Practicable Alternative (FONPA), for the Proposed Actions. The USAF is complying with Section 106 of the National Historic Preservation Act for the JVDP through consultation with the State Historic Preservation Officer and federally recognized tribes, and development of a project-based Programmatic Agreement under provisions of 36 CFR § 800.14(b)(3).
