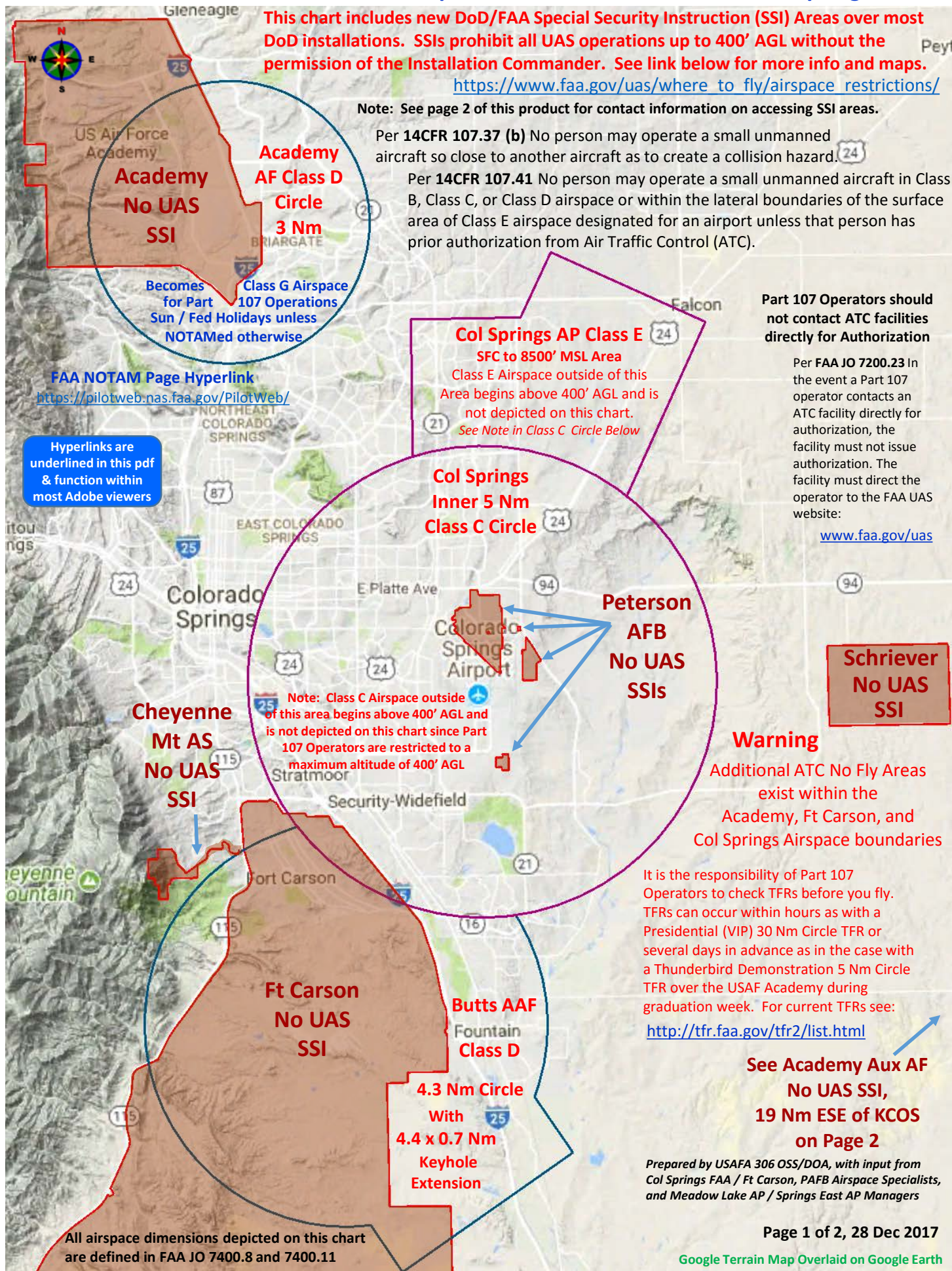

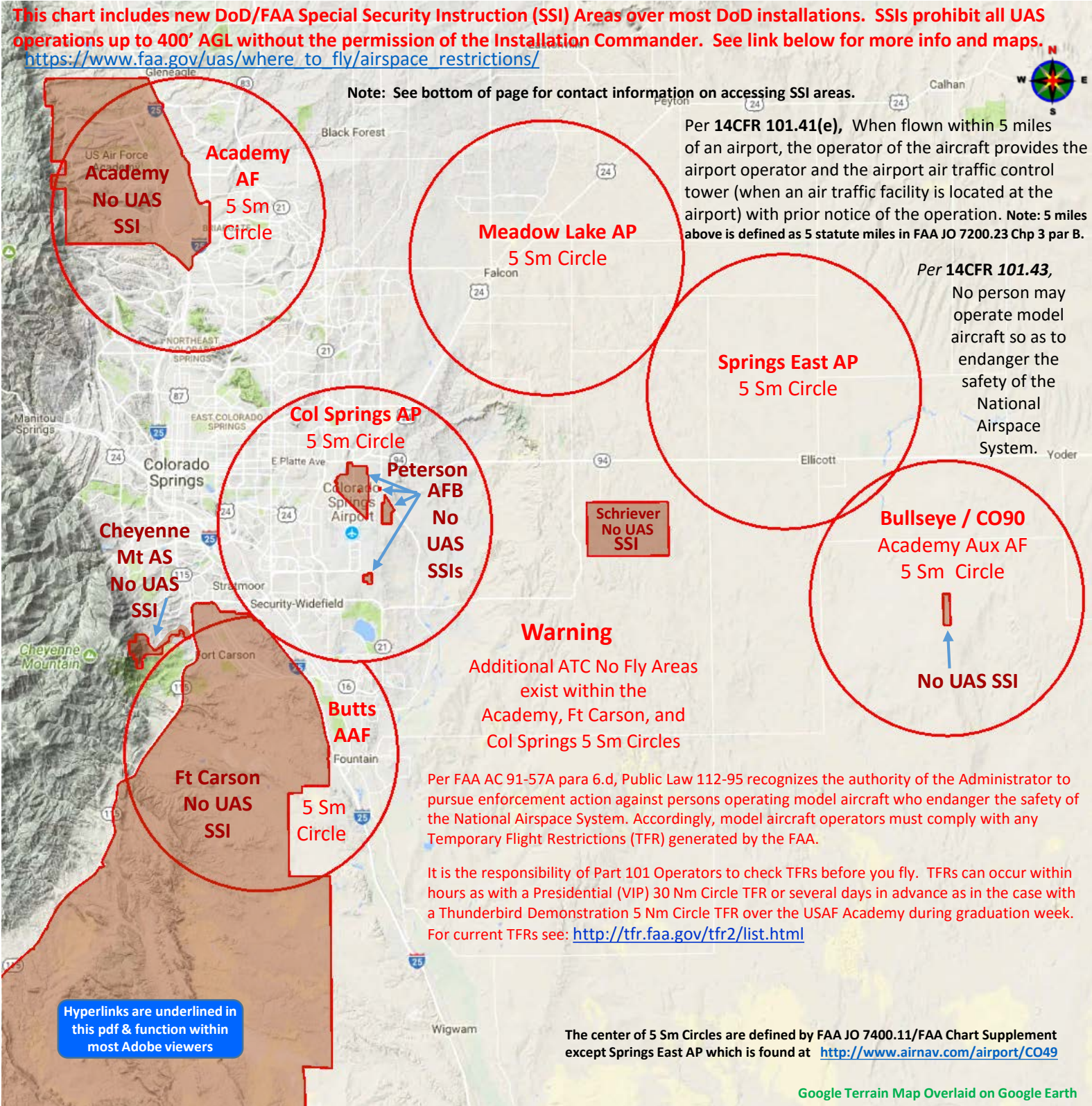
14CFR Part 101 (Hobbyist) sUAS Guide to Operations in the Greater Colorado Springs Area

This chart includes new DoD/FAA Special Security Instruction (SSI) Areas over most DoD installations. SSIs prohibit all UAS operations up to 400' AGL without the permission of the Installation Commander. Per 14CFR 101.41(e), When flown within 5 miles of an airport, the operator of the aircraft provides the airport operator and the airport air traffic control tower (when an air traffic facility is located at the airport) with prior notice of the operation. Note: 5 miles above is defined as 5 statute miles in FAA JO 7200.23 Chp 3 par B.

Per 14CFR 101.43, No person may operate model aircraft so as to endanger the safety of the National Airspace System.

Additional ATC No Fly Areas exist within the Academy, Ft Carson, and Col Springs 5 Sm Circles

Per FAA AC 91-57A para 6.d, Public Law 112-95 recognizes the authority of the Administrator to pursue enforcement action against persons operating model aircraft who endanger the safety of the National Airspace System. Accordingly, model aircraft operators must comply with any Temporary Flight Restrictions (TFR) generated by the FAA.

It is the responsibility of Part 101 Operators to check TFRs before you fly. TFRs can occur within hours as with a Presidential (VIP) 30 Nm Circle TFR or several days in advance as in the case with a Thunderbird Demonstration 5 Nm Circle TFR over the USAF Academy during graduation week.
